"What Home Means to Me" Poster Contest

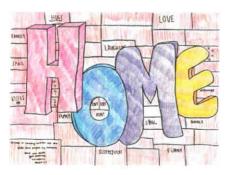

To all of you that follow this rule we really appreciate it. Remember before you place items at the curb for pick up call Public Works at 910-892-2948 before you place it beside the curb.

PET POLICY

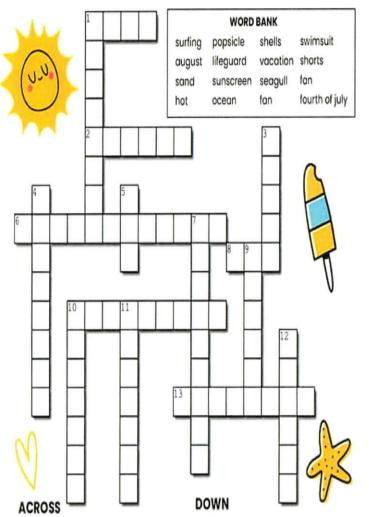
There is a 150.00 deposit for a pet. There is a 200.00 pet fee that should be paid before the pet enters your home. There is also a weight limit of 25 lbs. and that is for an adult pet. There are different types of pets that are not allowed Doberman Pinchers, Pit Bulls and Rottweilers. There is also information that is needed from the veterinarian, immunization records, tags and spay or neuter records. If you have a pet you are responsible for cleaning up after your pet yes even when they poop.

Why reporting household income is important.

Reporting changes in income need to be reported to Marsha at the Administrative office within 10 days of the change. When you contact me I will tell you that I will need proof if income has ended and 2 pay stubs if it is new income. This is important because HUD has a program called Enterprise Income Verification (EIV). This program reports income straight from the Social Security Office. When I find unreported income it is then calculated and the adjustment is made and may require a retroactive rent payment to be added to your monthly rent. For example, I started a new job March 1, 2021. I failed to notify my administrative office of the change. It did not show on the EIV report until the end of March. So now I have a full month of income that no rent has been paid on. My monthly income is 1500.00 and 30% is used to calculate my rent. So when I finally come into the office my rent is calculated and my new rent will begin May 1, 2021 but I will also owe 450.00 for the back rent because I did not report the income change within the 10 days. So please if you change jobs, if you are laid off a job, or you lose a job it is very important to report. It is also considered a lease violation if not reported.

Paying rent on time...

Do you realize that if your rent is paid late every month that you pay an extra 180.00 per year in rent. Also, history of late rent will follow you if you decide to rent somewhere else. Keep your account current and it will save you some money.







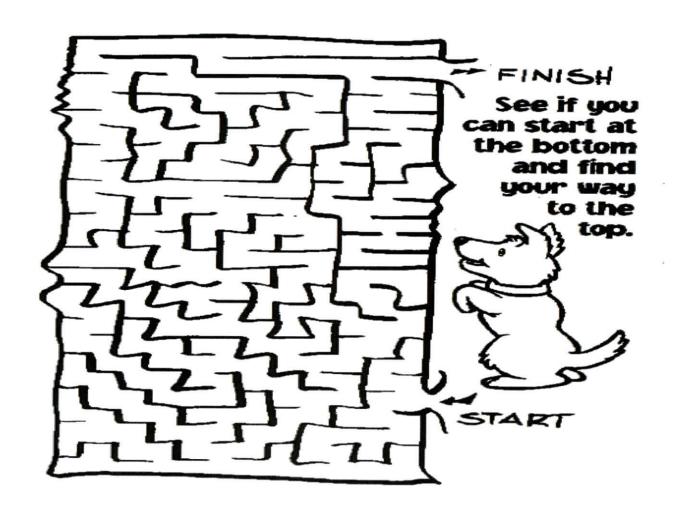
When you have a stopped up kitchen sink or bathroom sink after calling in the work order please remove your items from under the sink. It makes their job a little quicker when the resident assist with such items. If you have a work order please call it in. We will begin to start our annual inspections again and this will help the staff to come in and inspect and not have additional items that will have to be repaired. On April 29, 2021 Gregory Pest Control will be coming to do quarterly exterminating. I will send out a letter as a reminder. Just be prepared they will be coming in to your unit this time to spray. Make sure you have your mask on and they will have theirs on also.



One Strike Policy

Procedures for residents:

- The Housing Authority shall terminate the tenancy/ rental assistance of any resident who:
 - A. the Housing Authority has determined is illegally using a controlled substance; or,
 - B. the Housing Authority has determined that the resident's abuse of alcohol interferes with the health, safety, or right to peaceful enjoyment of the premises by other residents; or,
 - C. the Housing Authority has determined the resident to be engaging in drug-related criminal activity, either on or off the premises; or,
 - D. engages in any criminal activity that threatens the health, safety or right to peaceful enjoyment of the premises by other residents.



New Doors to be installed
